THE SITUATION

As a result of natural disasters, key public facilities are completely damaged or greatly diminished in delivering essential services to their communities.

This creates an urgency to restore and rebuild basic public infrastructure such as city halls, government centers, jails, schools, shelters, healthcare facilities, police and fire stations, as well as utility and road infrastructure. The burden falls on public agencies to rebuild as soon as possible, while simultaneously assisting the public's need and economic interests of their communities.

GULFPORT, MISSISSIPPI recovery efforts from Hurricane Katrina included the historic restoration of City Hall, a new police headquarters and municipal courts complex, nine firestation projects, seven community center projects, and a new leisure services administration building, and totaled \$78M.



LONG BEACH, MISSISSIPPI Hurricane Katrina recovery program totaled \$38.5M, including a new city hall, new fire station and first responders shelter, new harbor master building, extensive water, sewer, and road repairs, and harbor repairs.



If vital financial resources are to be effectively utilized, skillful project management is required.
